I hereby state that I have maintained the books and records of the Club in accordance with laid down accounting practices and the Rules of the Club.

The Statement of the Financial Position and the Income & Expenditure Statement reflect the financial position of the Club as at 30th June, 2019 and the operations of the Club for the period 1st July, 2018 to 30th June, 2019.

The Club has completed another year finishing with a deficit of \$156.12 and total current cash funds of \$3425.60.

Club Assets and Stock reflect the accounting records and are confirmed as held by Club Members as per the Asset Register attached.

The year's activity has seen a reduction in cash funds of \$512.12 since 30th June, 2018

Contributing factors were

Dining Income was \$1480 collected from members and paid out for Cervantes Christmas Dinner.

Morning & Afternoon teas at the SGM; AGM & Christmas cost \$186.94.

WAACCI Public Liability was reduced by \$235.

The Subscriptions increase was influenced by a \$10/van fee yielding an increase of \$266.

In my absence for the AGM, I have provided to the President, a detailed summary of each item of income and expense to enable any questions raised to be readily answered.

With the Anniversary Dinner planned for September and partly subsidised by the Club, the Committee will need to ensure current funds will be sufficient to cover the Club costs.
