GENERAL BUSINESS

After a brief discussion it was decided that new members be provided with information on where to find our Model Rules and By-Laws on our web site and that a copy be emailed to them.

Helen Bizzill asked when our Model Rules and By-Laws would be effective. Brian Bizzill said that they were effective as of today. David agreed they would be effective this day pending ratification from The Department of Mines, Industry Regulation and Safety. said. David asked Kevin Forbes if WAACCI had any problems getting the Model Rules approved and Kevin said that WAACCI did not have any problems at all and they went through in 9 days.

Alan Parkinson said that he would like to see a Table of Contents on our Model Rules and By-Laws.

Clelia Gough asked if page numbers could also be put in.

Ronnie Adams queried **By-Law No. 3. Members attendance Requirement** and read out the rule. Ronnie said that sometimes there is no accommodation at the rally site. Ronnie said that on one occasion she had to stay at a hotel. Helen Bizzill said that when we had a rally in Lancelin, Jim and Helen could stay at their house. Helen Schell said that, we are a caravan club and if we go home we are not part of the group. Roy Lundy suggested that this rule needs further discussion and perhaps it should be discussed by the Committee at a Committee meeting.

Alan Parkinson queried **By-Law No. 17. By-Laws** and said perhaps changes to By-Laws should be put to the members. Chris Young said that this is why we have a Committee, to make such decisions. Graham Gough said that he agreed. Brian Bizzill said that if the Committee makes a decision that Members don't agree with they can always go to Special General Meeting.

Roy Lundy said that when changes are made to the By-Laws the Members need to be notified.
